



Support for Virtual Learners in the Community Subgrant Application

The mission of 200,000 More Reasons is to have 100% of United Methodist Churches in Arkansas participate in an initiative to alleviate childhood hunger through feeding ministries, public witness, and education for long-term stability. 200,000 MORE Reasons expands the understanding of education and long-term stability to include such poverty alleviation strategies as literacy and promoting a healthy, stable family. We recognize that by working to alleviate poverty, we have the best opportunity for ending childhood hunger in Arkansas.

Virtual learning support for students fits within this mission as we seek to prevent a widening of the academic gap for those students with limited or no access to the internet. This sub-grant will offer financial assistance to AR United Methodist to ensure the proper technology is in place to support students in their learning. Participating students should be able to connect to online learning platforms, homework support and other school- and learning-related opportunities during the pandemic. We anticipate that many of these children served through this sub-grant may be from food insecure, low income families. Rural and more urban areas offer their own dynamics, but in all cases, our concern is for the student's learning potential.

The Methodist Foundation of Arkansas has awarded 200,000 More Reasons with a grant of up to \$25,000 to help provide financial assistance to churches seeking to offer Wi-Fi access on their church campuses/property to those students in their community who lack reliable access to the internet. Ministry designs may include, but are not limited to, internet access so that a) students can access virtual learning platforms from a local church's parking lot; b) a church may host family pods in Sunday school classrooms for virtual learning; or, c) a church may host students without a guardian in a large open space, like a gym, for virtual learning during limited hours.

This application is for those churches who need financial assistance in acquiring the technology and equipment necessary to implement their ministry design. This sub-grant is intended to cover one-time costs to expand broadband and internet access, up to 6 months of monthly rates, and/or other technological needs to host virtual learners on the church campus.

Please read carefully the requirements of this grant application. Grant amounts should be based on estimated costs with supporting documentation as requested below. We anticipate requests to be between \$500 to \$2,000. This is a reimbursement grant, meaning churches will need to submit for reimbursement for actual costs, not exceeding the awarded amount. Any actual costs above the awarded amount will be the responsibility of the subgrantee.

The strongest applications will:

- 1) Express financial need.
- 2) Show clear understanding of the technological needs for providing or expanding access to WIFI.
- 3) Demonstrate a well-thought out ministry design for your context, community and capacity to offer this support.

Items to note:

- 1) On November 2, 200,000 More Reasons staff hosted a zoom meeting with potential applicants. Discussion centered on ministry designs, technology and issues that arise for offering this type of ministry in the current context. If you were not part of this meeting, please listen to the recording before applying. - 2) As an applicant or a sub-grantee, you may be asked to join the staff in another zoom meeting to share best practices and to discuss concerns around ministry design, especially if you were not on the zoom meeting mentioned above.
- 3) You are encouraged to reach out to your local school(s) (school counselor, principal, etc.) and the library to assess community need; upload and download speed requirements for the virtual learning platforms; and, for assistance with communication to students who can participate.
- 4) We suggest assessing technological capability (bandwidth, etc.) for feasibility and cost effectiveness as one of your first steps. Recognize that any improvements made for this ministry will benefit other ministries as well.
- 5) If awarded, please take pictures, and collect stories of impact throughout your ministry to share on social media, with others and as part of the grant report mentioned below.

The grant request deadline period opens November 13 and will close January 30, 2021 or until the \$25,000 total has been committed to sub-grantees, whichever comes first.

**Your grant will not be awarded if the technological costs far exceed our capability to grant your requested amount or the church's ability to make up the difference, either through the budget, donations, or other grants.

- A) A letter from the Board of Trustees indicating approval of this project signed by the Pastor and Trustees Chair. This step is crucial to assure building and grounds use for this project is supported by the congregation.

This plan should indicate commitment to follow Covid-19 Safety Guidelines as set forth by the Governor of Arkansas, Bishop Mueller, and any other body that provides oversight, such as DHS if the church is a licensed childcare facility.

- C) A copy of your congregation's Safe Sanctuary policy signed by the project coordinator. Please make any adjustments necessary to ensure child safety for your proposed ministry design.
