



## 2023 Spring Grant Application

Our mission remains to have 100% of United Methodist Churches in Arkansas participate in an initiative to alleviate childhood hunger through feeding ministries, public witness, and education for long-term stability. 200,000 MORE Reasons expands the understanding of education and long-term stability to include such poverty alleviation strategies as literacy and promoting a healthy, stable family. We recognize that by working to alleviate poverty, we have the best opportunity for ending childhood hunger in Arkansas. These ministries can provide access to food now; greater learning potential for the child in the future; and, opportunities for living without food insecurity for the next generation.

### Priorities:

- 1) Seek to close the academic gap for students by offering support for grade level reading, especially for those ages 0 through grade 3. By offering in- or after-school reading help; summer literacy programs; school partnerships; and, building a child's personal library, children may learn to read to read to learn.
- 2) Promote a healthy, stable family for those children we serve in our communities. In opening our doors and ministries to those who face substance abuse crisis; who need greater physical, nutritional, emotional, and mental health literacy; and, who want stronger coping skills for their current life contexts, the church offers hope for a better future for food insecure children.
- 3) Increase access to food for children, particularly during school breaks and over the weekend, through food distribution, meals, gleaning, and community gardens.

200,000 More Reasons small grants **of up to \$2,000** will be awarded through a competitive process. Any United Methodist church, group or organization may apply. Congregations voting to disaffiliate must be able to spend in full the amount granted before the next Annual Conference that will be addressing your church's disaffiliation. If one is applying on behalf of a ministerial alliance or as part of a community or faith-based partnership, then congregational volunteer activity with these groups should be part of the ministry design and expressed in the grant application.

### The strongest applications will:

- 1) Express strong financial need.
- 2) Intentional focus on food-insecure children in its ministry design except for those that will promote a healthy, stable family. These may involve the guardians of food-insecure children.
- 3) Show understanding of the social issues and conditions specific to your community that calls you to action.
- 4) Incorporate a design that includes more than one priority as listed above.

- 5) Not be for the same ministry design previously awarded, especially if granted multiple years.

Examples of a feeding ministry that is **MORE** may be one that offers a support group for grandparents met through a feeding ministry or one that distributes books to children that receive backpacks of food. Other examples are ministries that offer reading skills enrichment for students plus a healthy snack or parenting workshop.

### **Those applying must at a minimum**

- 1) meet at least one of the priorities listed above
- 2) demonstrate a ministry design that focuses on serving food-insecure children ages 0-18
- 3) be a NEW ministry or clearly show an expanded design of previously granted ministries
- 4) begin the Spring or Summer of 2023. For those ministries that will begin in Fall/Winter, please wait for the next application cycle to be announced for later in 2023.

### **Items to note:**

- 1) If your church has received a grant in the past for a feeding ministry for which you are applying again then clearly explain why continued support from this small grant is necessary.
- 2) Those awarded a grant in Fall 2022 may not apply for the same ministry.
- 3) Ministries that begin operation in the Fall or Winter of 2023 DO NOT APPLY FOR THIS GRANT. There will be a separate granting process as noted above. Any submissions will not be awarded.
- 4) The Grant Review Committee prefers not to fund the purchase of school supplies or one-time events.

- 7) If funds are granted, a written report describing use of the funds must be submitted before September 8. A report form and more information will be provided closer to time.

### **Applying:**

- 1) Complete the application **after** reading the above carefully.
- 2) Applications are **due Friday, March 10th**
- 3) The online application system does not save or allow you to go back and edit your work. Consider typing the answers to each question and copying it into the online application. Online submissions are preferred since other formats must be entered by hand by staff.

3. List at least 1 goal that you have for this ministry, including but not limited to the number of children you hope to impact. Make the goal(s) easily measurable. Some examples include the number of children involved in summer reading; the number of books distributed through weekend backpack food; the number of households with children given food; or, the number of food pantry visitors involved in small group setting.
4. If this ministry is a project for which you received a grant for previously, how does this request expand or differentiate itself from that prior grant application?
5. Provide a budget for the ministry. Include expenses (name/type) and estimated amounts/costs. What percent of the total budgeted cost of your ministry does this grant request cover?
6. Provide a budget narrative: describe your financial need; and, explain budgeted costs where helpful. If this grant award will meet specific budget items, indicate which one(s). What partners or other financial resources do you have? How will you fund this ministry beyond this grant?

7. Does this ministry involve other local United Methodist church(es)? Which ones and what are the respective roles for each?
8. Did the church pay tithe apportionments in the previous year? (circle) Yes No
9. Is your church in the disaffiliation process? (circle) Yes or No If yes, which session of the Annual Conference do you anticipate your church will be voted on?
